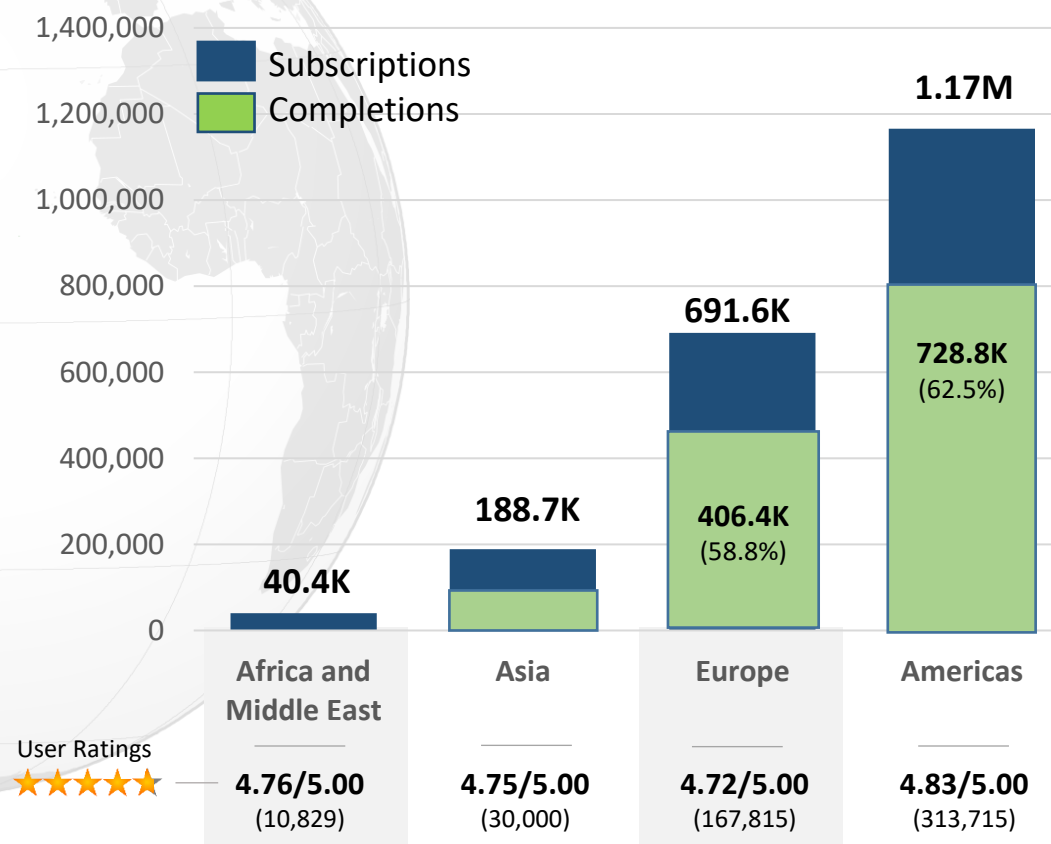

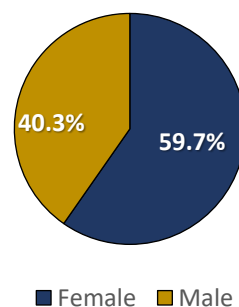

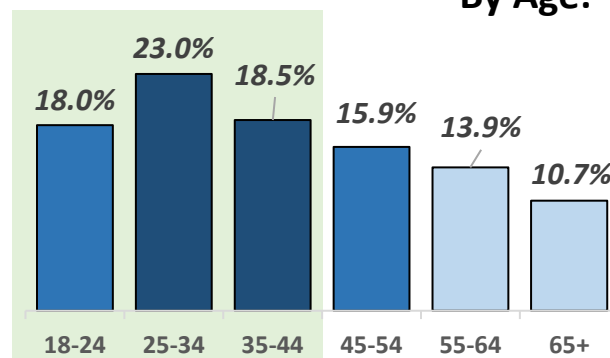
# Global Readership Demographics

## By Gender:

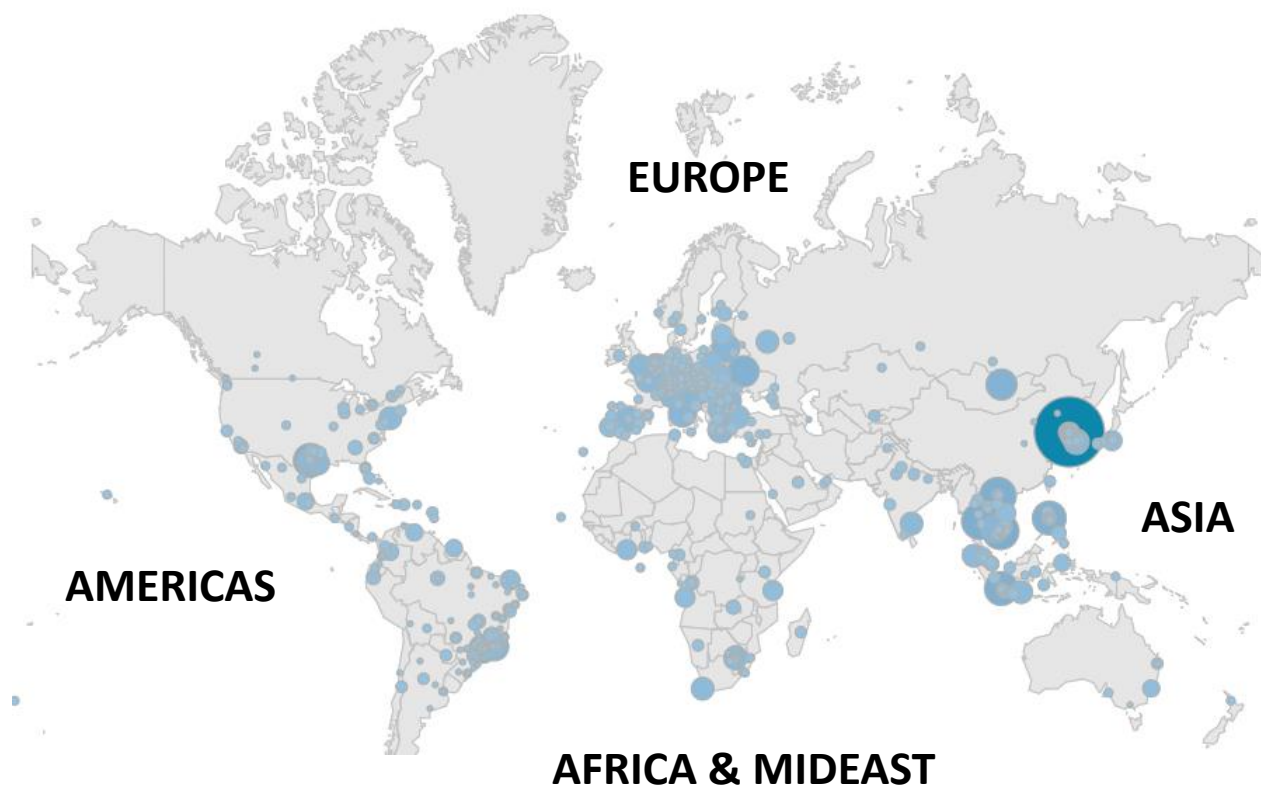


## By Age:

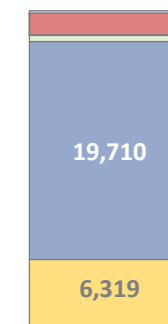
